Minutes of a Meeting of the Parish Council held in Holne Village Hall on Tuesday 7 December 2021 at 7.30pm

071221.02	Declarations of Interest and Requests for Dispensation <p>Members were reminded of their responsibility to continually update their Notice of Registerable Interests and invited to state whether they have any interest in the items to be discussed during this meeting in accordance with the Council's Code of Conduct.</p> <p>Unforeseen requests for a Dispensation to be considered at this point only if there was no way a Councillor would have been aware of such before the meeting.</p> <p>There were no declarations of interest and requests for dispensation.</p>
071221.03	Open Forum <p>There were no comments.</p>
071221.04	County Councillor, District Councillors' and DNPA Reports <p>District Cllrs Pannell and Smerdon submitted a written report (attached).</p> <p>County Cllr Thomas submitted a written report (attached). He had noted the correspondence regarding the pothole on the section of road behind Bakers Park and advised that the Highways Engineer, Nick Colton, would be visiting the site tomorrow to look at it. Cllr Crook suggested that when the repair is undertaken, the contractors might also be able to create a tarmac lip at the top of Hilltop's drive to divert water running down the road.</p> <p>Cllr Smerdon submitted a written report as DNPA representative (attached).</p>
071221.05	Ratification of Minutes <p>This item was deferred until January's meeting as the minutes had not yet been circulated.</p>

<p>071221.07</p>	<p>Planning</p> <p>7.1 New applications/appeals</p> <p>7.1.1 0611/21 & 0612.21 – Long Barn, Michelcombe Conversion back to former use as dwelling</p> <p>Members agreed not to comment on this application.</p> <p>7.1.2 0671/21 – Langaford, Holne Alterations to ancillary building</p> <p>It was agreed that Cllr Crook would try and visit the site before making any comment.</p> <p>7.2 Decisions</p> <p>7.2.1 0395/21 – Sky Garden, Holne Replacement dwelling, garage, outbuildings, new swimming pool and landscaping</p> <p>Members noted that DNPA has granted conditional planning permission. It was noted that there was a number of planning conditions. However, addressing a point raised by the Parish Council regarding taking water from a leat, it was observed that the planning officer did indicate that the leat is to be utilised within the garden landscaping and the use of the water is not an issue to be dealt with in the planning assessment. There followed a discussion about the 'rules' relating to the leat system and its maintenance. After discussion, it was agreed that Cllr Applegarth would try and speak to the Reeve of the Manor (Phil Cleave) and the Steward of the Manor (Chief Executive of DNPA) to establish whether there are any leat 'rules' and how these are enforced.</p> <p>Members also noted an email from a parishioner to DNPA, which the Parish Council had been copied into, expressing disappointment about this decision and concerns about the scheme of delegation. DNPA's response was also received and noted.</p> <p>7.3 Other planning matters</p> <p>Church House Inn – members noted that DNPA's Enforcement Officer has visited the pub and spoken to the new owner. He was informed that they have spent the last three months emptying the property of rubbish, upgrading the electrics, removing the bunk house at the rear, cleaning the chimneys and repairing the cracked render on the chimneys. The owner has other works in mind and are aware that Listed Building Consent may be required. The Conservation Officer has also been appraised of developments and is aware of the situation.</p>
<p>071221.08</p>	<p>Highways and Footpaths</p> <p>8.1 Members received a response from DNPA Ranger, Bill Allen, regarding the heavily eroded footpath to Holne Woods from Hilltop. He advised that he will have a look and report back as to what we might be able to do to improve things although he confirmed that this will be due in part to the leat breaching beside the road and any resurfacing material that is laid will just wash out in the next heavy rain. Members discussed landowners' responsibility for maintaining the different sections of the leat in this location including the section under the road. Cllr Applegarth will make some further enquiries.</p> <p>8.2 There were no new highways or footpaths matters reported.</p>
<p>071221.09</p>	<p>Playpark</p> <p>9.1 Cllr Bellamy reported that the maintenance day took place on 13 November and was very productive. The sump has been cleared out but debris has built up under the clapper bridge which will require digging out with a digger. The hedge has been trimmed.</p>

	9.2 Cllr Bellamy advised that he is continuing to pursue Earthwrights with regards to the defects which have been raised by SHDC Localities Officer.
071221.10	Leats There were no further matters other than those previously raised and already discussed in the meeting.
071221.11	Queen's Platinum Jubilee Members discussed the Queen's Platinum Jubilee and whether the village will be planting a tree to commemorate this. Possible locations were discussed. It was agreed that there should be a discussion with the church and events organising group about how the community can commemorate the event.

Helping residents to pay essential bills this winter

As the winter cold starts to bite, South Hams District Council invites households experiencing financial hardship to get help with paying essential bills. The council will be handling applications for the Government's new Household Support Fund from today, 15 November 2021, and throughout the winter. There's also a reminder of other support available to residents who are struggling to make ends meet over the coming months.

The new Household Support Fund is designed to provide rapid short-term financial support for people who don't have enough money to buy essentials like food or pay for heating. Anyone over 16 years old in the South Hams could be eligible, but you will need to confirm that your need is genuine. These grants aim to help people to meet daily needs such as food, clothing and utility bills. Payments will be made directly into your bank account. Residents without a bank account should contact us.

As well as being the place to apply for Household Support Fund money, there are other ways the Council can help local people in crisis situations. This includes help with making adaptations to your home to help you to live their independently, support for people threatened with homelessness or struggling to pay their rent and help to reduce energy costs. The Council also works closely with a number of other agencies that provide more specific support and can help signpost residents to access all the help available.

All you need to do is go online or call 01803 861234. But the support we can offer does not stop there. We can also help to signpost residents to help with paying housing costs, reducing energy bills and provide assistance so people can carry on living in their home independently. We have a member of staff on hand to help individuals and community groups to access all that is available or you can also ask your local councillor for advice."

Devon County Council led the bid for a share of the government funding, securing a little over £5 million for the county.

South Hams District Council's support for local communities extends beyond helping individuals in crisis situations. It has been working closely with the voluntary sector as well as Devon County Council and the NHS to provide grants and support to reduce health inequalities and rural poverty. This includes investing £4m to develop an integrated health hub in Dartmouth.
